**ARTICLES OF ORGANIZATION
FOR
LAUTEN CONSULTING, LLC**

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, acting as the organizer of LAUTEN CONSULTING, LLC, under the Florida Revised Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**


**ARTICLE IV

MANAGEMENT**


