ARTICLES OF ORGANIZATION  
OF  
B&B PALM HARBOR HOLDINGS LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be "B&B PALM HARBOR HOLDINGS LLC" (the "Company").

ARTICLE II -- ADDRESS

ARTICLE III -- DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. 


