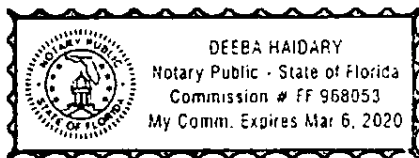
1. I am the CEO of AGIA PROPERTIES, INC.

3. I have no intention of revoking the dissolution, therefore, releasing the name for use to another entity.

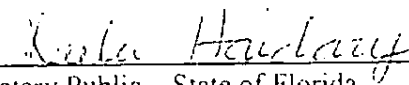
