Pursuant to the provisions of Section 605.0202, Florida Statutes, this Florida limited liability company adopts the following Articles of Amendment to its Articles of Organization:

- A. The name of this Company is **BUDDY & BUG, LLC**
- B. The Articles of Organization of this Company were filed on August 15, 2019.
- C. The Articles of Organization are hereby amended to add the following Article V:

"Article V

"The sole purpose for which the Company is formed is to operate franchised Chick-fil-A Restaurant business(es) under a Franchise Agreement with Chick-fil-A, Inc. and to exercise all other powers necessary to, or reasonably connected with, the operation of the franchised Chick-fil-A Restaurant business(es)."

There are no other amendments to the Articles of Organization, except as stated above.
