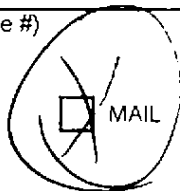

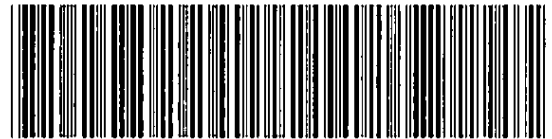

**ARTICLES OF ORGANIZATION OF

The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in and require approval of a majority of its Members.


**ARTICLE VII


