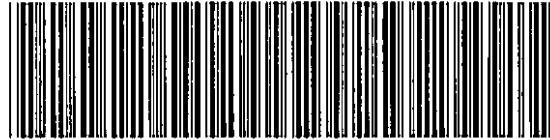

Wealth Integration LLC. Because Chirawat Withanwattana is the one who operate, making decision the business.


