

## ARTICLES OF ORGANIZATION OF LOTUS MEDICAL TECHNOLOGIES LLC

SECRETARY OF STATE TALLAHASSEE, FL

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I NAME

The name of the Limited Liability Company shall be LOTUS MEDICAL TECHNOLOGIES LLC ("Company"). The principal place of business of the Company in Florida shall be 9125 NW 33rd Street, Doral, Florida 33172, and the mailing address shall be PO Box 137 Haymarket, Virginia 20168.

These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
