**ARTICLE I

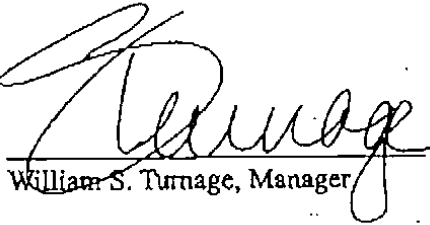
