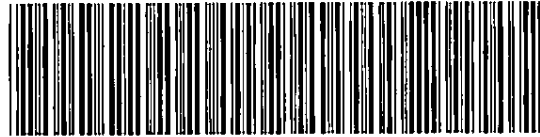

ARTICLE VI- TERMINATION OF EXISTENCE

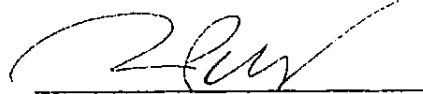
