


ARTICLES OF CONVERSION



**ARTICLES OF ORGANIZATION**  
**FOR**  
**THE ROSES' HOME HEALTHCARE, LLC**  
*(A Florida Limited Liability Company)*

*The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, pursuant to the Florida Revised Limited Liability Company Act (the "Act"), hereby adopts the following Articles of Organization:*

**ARTICLE 1**

**NAME**

The name of the Limited Liability Company is THE ROSES' HOME HEALTHCARE, LLC (the "Company").

**ARTICLE 2**

**DURATION**

The Company shall exist on the date of filing of these Articles with the Secretary of State of the State of Florida. The duration of the Company shall be perpetual.

**ARTICLE 3**

**NATURE OF BUSINESS**

The Company is organized for the purpose of transacting any and all lawful business permitted under the Act.

**ARTICLE 4**

**ADDRESS**

The initial principal address of the Company is 340 Corporate Way, Suite 150, Orange Park, Florida 32073.

**ARTICLE 5**

**INITIAL REGISTERED AGENT AND REGISTERED OFFICE**

**ARTICLE 6**

**MEMBERSHIP CERTIFICATES**

Each Member's interest in the Company may be evidenced by a membership participation or unit certificate. No Member of the Company may transfer, sell or assign its membership interest or unit in the Company to any other person except as provided for in the Company's Operating Agreement.

**MANAGEMENT**


The Company shall be member-managed. The initial member shall be Concierge Home Care of Jacksonville, L.L.C., a Florida limited liability company.


