**ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is JONES HILLS GOLF, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Effective Date and Duration. The Company's existence shall be effective as of August 30, 2019, and shall thereafter be perpetual.

4. Place of Principal Office. The mailing and street address of the Company's principal office is 10688-D Crestwood Drive, Manassas, Virginia 20109.


