TO THE

Pursuant to the requirements of Section 605.0202, Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment to the Articles of Organization of Weaver Family Trust, LLC (the "Company"), which Company was organized under the laws of the State of Florida on August 21, 2019, document No: L19000217370 :

1. Article I of the Company's Articles of Organization is hereby amended by deleting in its entirety the existing Article I and replacing it with the following:

"ARTICLE I

Name and Duration

The name of this Limited Liability Company is **Weaver Family Holdings, LLC** (hereinafter referred to as the "Company"). The duration of the Company shall commence upon the filing of these Articles of Organization and shall be perpetual."
