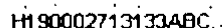

Articles of Organization

of

DC-Tech of Florida, LLC

A Florida Limited Liability Company

1. Name

The name of this limited liability company is DC-Tech of Florida, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 605, Florida Statutes.

2. Duration and Purpose
