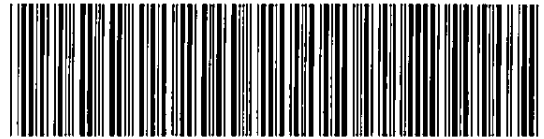

low for several years and this has had a negative affect on landowners.


