
#### ARTICLE VII –Members

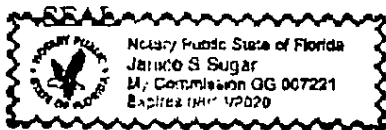
