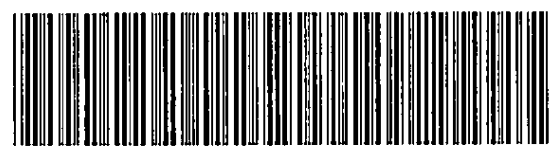

ARTICLES OF ORGANIZATION
OF
BRISTOL LAKES PHASE II, LLC

The undersigned organizer, who is the authorized representative of the sole Manager of Bristol Lakes Phase II, LLC, a Florida limited liability company (the "Company") under the Florida Revised Limited Liability Company Act (the "Act"), hereby adopts the following Articles of Organization (the "Articles").

ARTICLE 1 - NAME

The Agreement of the Company shall be initially approved and adopted by a majority vote of the Members of the Company.

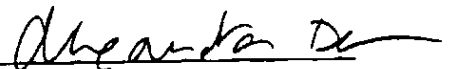
