**ARTICLES OF ORGANIZATION
OF
MPS CKS, LLC**

1. Name. The name of this limited liability company is MPS CKS, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Effective Date and Duration. The Company's existence shall be effective as of September 12, 2019, and shall thereafter be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
