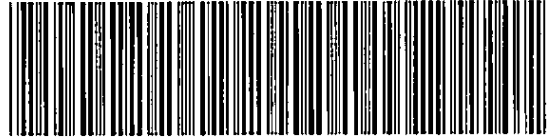

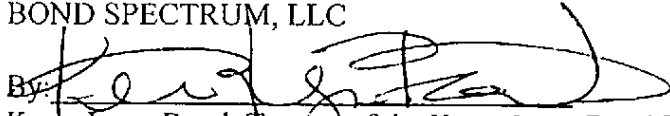

### ARTICLE II - Address

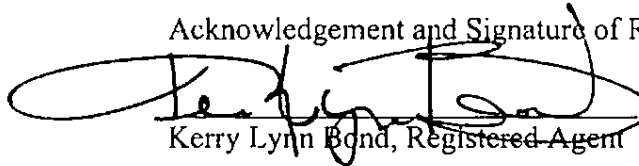
