**ARTICLE VII - MEMBER'S RIGHTS TO CONTINUE BUSINESS**

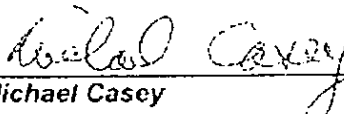
