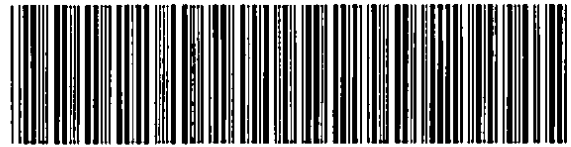

Pursuant to the provisions of section 605.0202, Florida Statutes, this Florida Limited Liability Company adopts the following amendment to its Articles of Organization:

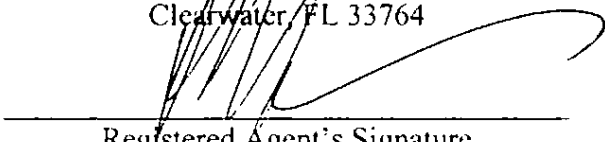
**FIRST:** The Articles of Organization for this Limited Liability Company were filed on SEPTEMBER 23, 2019 and assigned Florida document number L19000232350.

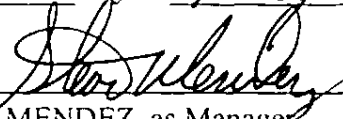

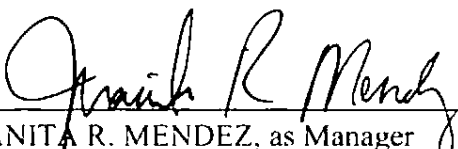
written agreement and/or certificate of ownership whether Membership Interests that they are acquiring are voting or non-voting.

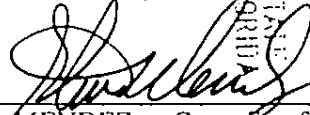

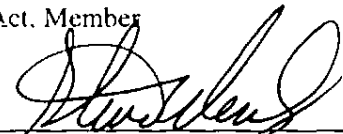
