## ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF JERRY'S MARINE ACQUISITION FL, LLC (a Florida limited liability company)

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act (the "<u>Act</u>"), JERRY'S MARINE ACQUISITION FL, LLC, a Florida limited liability company (the "<u>Company</u>"), adopts the following Articles of Amendment to the Articles of Organization:

- 1. The name of the company is Jerry's Marine Acquisition FL, LLC.
- 2. The Company's Articles of Organization were filed with the Florida Secretary of State on September 25, 2019 and assigned Florida document number L19000234657.

3. Article I of the Company's Articles of Organization is hereby deleted and replaced in its entirety with the following new Article I:

## ARTICLE I
