

## ARTICLES OF ORGANIZATION OF BEACON WEALTH PLANNING LLC

The undersigned, for the purpose of forming a limited liability company under the Flonda Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.
