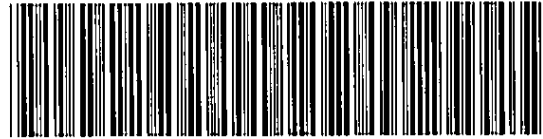

**ARTICLES OF ORGANIZATION  
OF  
RASMUSSEN LEGAL PLLC**

The undersigned authorized representative executes these Articles of Organization to form a professional limited liability company under the Florida Professional Service Corporation and Limited Liability Company Act:

**ARTICLE I. NAME**

The name of the professional limited liability company is Rasmussen Legal PLLC.

**ARTICLE II. ADDRESS**

The mailing and street address of the principal office of the professional limited liability company is:

**ARTICLE III. REGISTERED AGENT AND OFFICE**

**ARTICLE IV. MANAGEMENT OF COMPANY**

The business of the professional limited liability company will be managed by one or more managers who will be elected or appointed by the member or members of the professional limited liability company in the manner set forth in its Operating Agreement. A member of the professional limited liability company does not have any authority to incur any contractual liability or obligation on behalf of the professional limited liability company, unless the member is also a manager of the professional limited liability company.

**ARTICLE V. PURPOSE**

The purpose of the professional limited liability company is to engage in the practice of law through its agents, officers, and employees who are duly licensed or otherwise legally authorized to render those professional services within the State of Florida. The professional limited liability company shall not engage in any business other than the practice of law.

**ARTICLE VI. MEMBERS**

Every member of the professional limited liability company must be an individual, professional corporation, or professional limited liability company that is duly licensed or otherwise legally authorized to practice law in the State of Florida. The professional limited liability company shall not issue a membership interest to anyone who is not duly licensed or otherwise legally authorized to practice law in the State of Florida. A member of the professional limited liability company shall not transfer a membership interest in the professional limited liability company by gift, sale, exchange, or other means to anyone who is ineligible to be a member of the professional limited liability company, and any attempted transfer to an ineligible person will be invalid. Further, a member of the professional limited liability company shall not enter into a proxy, voting trust, voting agreement, or any other agreement or arrangement that vests in a person who is ineligible to be a member of the professional limited liability company the authority to exercise any voting power of the member membership interest in the professional limited liability company, and any such trust, agreement, or arrangement will be invalid with respect to the professional limited liability company and its members.
