**ARTICLES OF ORGANIZATION

The undersigned, Elizabeth Paige Rawson, a natural person competent to contract and an authorized representative of 14th Ave Beach Body House, LLC, hereby presents these Articles of Organization as the Articles of Organization of 14th Ave Beach Body House, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is 14th Ave Beach Body House, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS


ARTICLE VI - MANAGEMENT


