ARTICLES OF ORGANIZATION ROGUE RACING, LLC, A FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I. NAME

The name of the Limited Liability Company is "Rogue Racing, LLC" (the "Company").

ARTICLE II. **ADDRESS**
