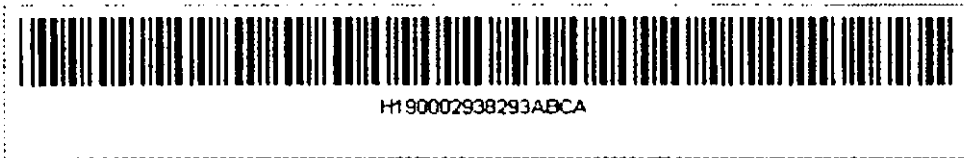

The name of the limited liability company is: WHITNEY LOGISTICS SOLUTIONS, LLC.


