ARTICLES OF ORGANIZATION
OF
ORLANDO REDIRECT LLC

Pursuant to the provisions of Chapter 605 of the Florida Statutes (the "Florida Revised Limited Liability Company Act"), the undersigned representative of the members, for the purposes of forming a Florida Limited Liability Company, hereby adopts the following Articles of Organization:

ARTICLE 1

NAME

The name of the company is ORLANDO REDIRECT LLC, (the "Company")

ARTICLE 2

DURATION AND PLACE OF BUSINESS

The period of duration of the Company is perpetual and its principal place of business is at 1130 S Powerline Rd, ste 105A, Deerfield Beach, Florida 33442. The liability of the managers and managing member of the Company for monetary damages shall be eliminated to the fullest extent permissible under Section 605.04093 of the Florida Revised Limited Liability Company Act.

ARTICLE 8 INDEMNIFICATION OF COMPANY'S AGENTS.

Subject to the applicable limits set forth in Section 605.04093(2) of the Florida Revised Limited Liability Company Act, the Company is authorized to provide indemnification of its members, managers, managing members, officers, employees, and agents through operating agreement provisions.
