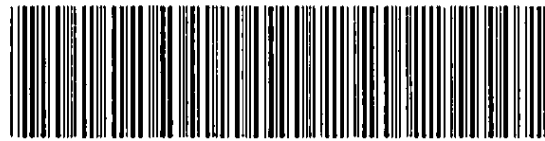

"Article VI


