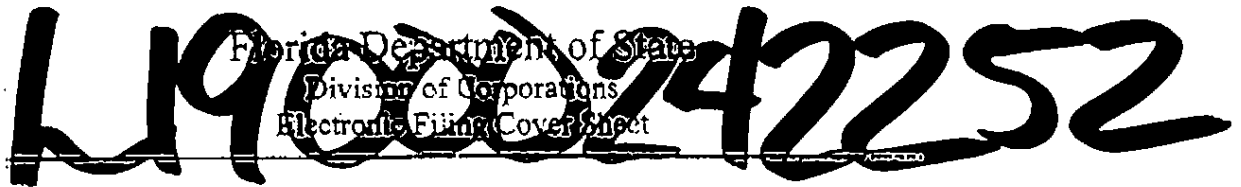

**ARTICLES OF AMENDMENT  
to

Pursuant to the provisions of Section 605.0202, Florida Statutes, Chet's Farm, LLC, a Florida limited liability company (the "**Company**"), adopts the following Articles of Amendment to amend its Articles of Organization:

**FIRST:** The Articles of Organization for the Company were filed on October 7, 2019 and assigned Florida document number L19000242252.

**SECOND:** Article VI shall be deleted in its entirety and the following shall be inserted in its stead:

**"Article VI**


