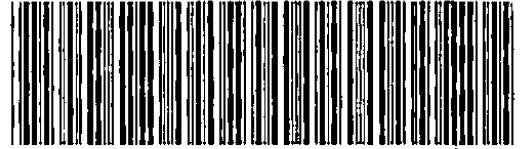



NAME


