**ARTICLES OF ORGANIZATION  
OF  
AHP DEVELOPMENT, LLC**

The undersigned, Arthur Fletcher II, a natural person competent to contract and an authorized representative of AHP DEVELOPMENT, LLC, hereby presents these Articles of Organization as the Articles of Organization of AHP DEVELOPMENT, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I – NAME**

The name of the limited liability company is AHP DEVELOPMENT, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

**ARTICLE II – PRINCIPAL OFFICE ADDRESS**

The street and mailing address of the Company’s initial principal office is 815 S. Palafox Street, 3<sup>rd</sup> Floor, Pensacola, FL 32502.

**ARTICLE III – PURPOSE AND POWERS**

**ARTICLE IV – COMMENCEMENT AND TERM OF EXISTENCE**

**ARTICLE V – REGISTERED OFFICE AND AGENT**

**ARTICLE VI – MANAGEMENT**


