

#### EXCULPATION OF LIABILITY: INDEMNIFICATION.

- EXCULPATION OF LIABILITY, Unless otherwise provided by law or expressly assumed, a person who is a Member, shall not be liable for the acts, omissions, representations, covenants, debts or liabilities of the Company, to the extent permitted by the Act.
- 2. INDEMNIFICATION BY THE COMPANY. Except as otherwise provided in this Article, the company shall indemnify any Member of the Company who was or is a party or is threatened to be made a party to a threatened, pending or completed action, suit or preceding, whether civil, criminal, administrative, or investigative, and whether formal or informal, other than an action by or in the right of the Company, by reason of the fact that such person is or was a Member, to the extent permitted by the Act.
- 3. INDEMNIFICATION APPLIED AGAINST EXPENSES. Any indemnified person shall be indemnified against expenses, including attorney's fees, judgments, penalties, fine and amounts paid in settlement actually and reasonably incurred by such indemnified person in connection with the action, suit or proceeding, only if the indemnified person acted in good faith, with the care an ordinarily prudent person in a like position would exercise under similar circumstances, and in a manner that such indemnified person reasonably believed to be in the best interests of the Company and, with respect to a criminal action or proceeding, if such indemnified person had no reasonable cause to believe such indemnified person's conduct was unlawful.
- 4. SUCCESS OF PERSON. To the extent that an indemnified person has been successful on the merits or otherwise in defense of an action, suit or proceeding or in defense of any claim, issue or other matter in the action, suit or proceeding, such indemnified person shall be indemnified against actual and reasonable expenses including attorney's fees, incurred by such indemnified person in connection with the action, suit or proceeding brought to enforce the mandatory indemnification provided in this Agreement.
- EVENTS OF INDEMNIFICATION. Any indemnification permitted under this Article, unless ordered by a court, shall be made by the Company only as authorized in the specific case.
