## ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF WELDON CROSSINGS MANAGER LLC

The undersigned, as a manager of WELDON CROSSINGS MANAGER LLC, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to the terms of Chapter 605, <u>Florida Statutes</u>, the Florida Revised Limited Liability Company Act (the "Act"), states as follows:

- 3. The Articles are amended by deleting Article IV in its entirety and replacing with the following:
