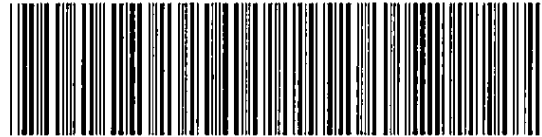

**Management**




