**ARTICLES OF ORGANIZATION
OF

The undersigned, LAMAR E. ROBINSON, M.D., a natural person competent to contract and an authorized representative of TRINITY IMAGING, LLC, hereby presents these Articles of Organization as the Articles of Organization of TRINITY IMAGING, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is TRINITY IMAGING, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial principal street address of the Company is 5151 North 9th Avenue, Pensacola, FL 32504, and the initial mailing address of the Company is P.O. Box 9210, Pensacola, FL 32513. ARTICLE III - PURPOSE AND POWERS
