Pursuant to the provisions of section 605.707, Florida Statutes, this limited liability company adopts the following Articles of Dissolution to its Articles of Organization:

- FIRST:** The name and address of this Company is **MARVELOUS CREATIONS INTERNATIONAL L.L.C.**, 4473 South Indian River Drive, Ft. Pierce, Florida 34982.
- SECOND:** The Articles of Organization were filed on October 17, 2019 and assigned document number L19000251517.
- THIRD:** The date of the adoption of these Articles of Dissolution is 6 October 2022.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 605.0709.
