

# ARTICLES OF ORGANIZATION of SONGBROOK, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

#### ARTICLE I

#### NAME

The name of the limited liability company shall be Songbrook, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 2552 St. Augustine Blvd., St. Augustine, Florida 32086.

#### **ARTICLE II**

#### PURPOSES AND POWERS

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.

### MANAGER

The managers shall be elected in the manner set forth in the Operating Agreement of the Company.
