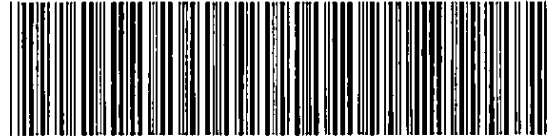

ARTICLES OF ORGANIZATION OF
THREE S3 PLUS LLC

Pursuant to Chapter 605, Florida Statutes, the undersigned, being a natural person over the age of 18 years, and being a member or an authorized representative of a member of THREE S3 PLUS LLC, hereby forms a limited liability company.

Article 1
(Name)

The name of the limited liability company is THREE S3 PLUS LLC.

Article 2
(Duration)

The duration of the limited liability company shall be perpetual.

Article 3
(Initial Principal Office)

In the event of death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, upon unanimous

written consent, the remaining members shall have a right to continue the business of the limited liability company.

Article 7
(Management)

The affairs of the limited liability company shall be managed by one or more managers who shall be elected by and hold such offices as may from time to time be determined by a majority of the members of the limited liability company. The name and address of the initial manager of the limited liability company who shall serve until the first annual meeting or until his successors are duly elected and qualified shall be Tharcisio Araujo Dias de Souza Santos, whose address is 1507 Hubbard Court, Celebration, Florida 34747

Article 8
(Transferability of Member's Interest)

No member may assign, in whole or in part, his membership interest in the limited liability company without the unanimous written consent of the non-assigning members.

Article 9
(Membership Classes)

The Operating Agreement of the company may provide for one or more classes of members, with or without voting rights, and having such other relative rights, powers, and duties as the Operating Agreement may from time to time provide.

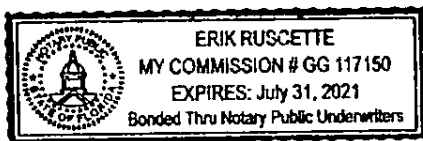


