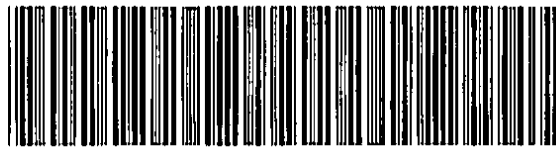


ARTICLE VII - Members


