





The undersigned subscribers to these Articles of Organization, natural persons competent to contract, hereby forms a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liabilities companies for profit. They further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

Article I. Name and Principal Place of Business

The name of the limited liability company will be **R & M Beach Club, LLC**. Its principal office and mailing address will be located at 298 Winchester Drive, Saline, MI 48176.

Article II. Exercise of Powers

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of, the members of this limited liability company. These Articles of Organization may be amended from time to time in the regulations of the limited liability company by a unanimous vote of the members of the limited liability company.

Article III. Management

Management of this limited liability company is reserved to its organizers and members, whose names and addresses are as follows.

Article IV. Membership Restrictions

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

A member's interest in the limited liability company may not be sold or otherwise transferred except with unanimous written consent of all members.

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on unanimous consent of the remaining members.

#### Article V. Capital Contributions

Capital contributions in an amount to be determined by the members shall be paid to the limited liability company by the members in equal shares. Additional contributions will be made as required for investment purposes, as determined by unanimous consent of the members. Members will make contributions in equal shares.

#### Article VI. Profits and Losses

(a) Profit Sharing. The members shall be entitled to the net profits arising from the operation of the limited liability company business that remain after the payment of the expenses of conducting the business of the limited liability company. Each member shall be entitled to an equal distributive share of the profits or the distributive share of the profits specified as follows:

Dominic Maniaci and Maureen Maniaci, as tenants by the entireties	50%
Robert Paul Ryan, as Trustee of the Robert Paul Ryan Living Trust, dated June 23, 1994	50%

The distributive share of the profits shall be determined and paid to the members each year on the anniversary date of the commencement of business of the limited liability company, the month and day of the commencement date being October 22, 2019.

(b) Losses. All losses that occur in the operation of the limited liability company business shall be paid out of the capital of the limited liability company and the profits of the business, or, if these sources are insufficient to cover such losses, by the members in equal shares.

#### Article VII. Effective Date

The effective date of this limited liability company and these Articles of Organization is October 22, 2019.

#### Article VIII. Duration


This limited liability company shall exist until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.

Article IX. Initial Registered Office and Registered Agent


