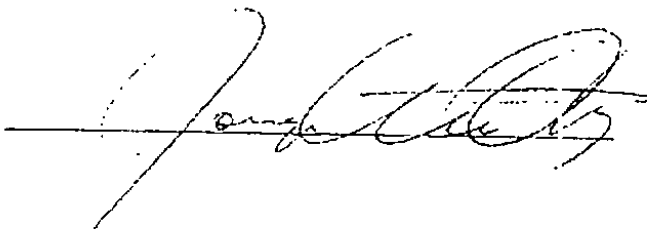

Article IX

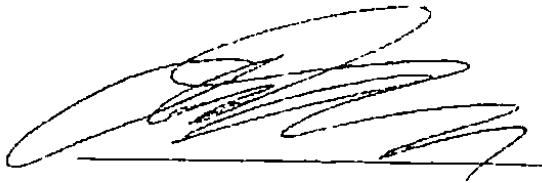
Continuity of Life

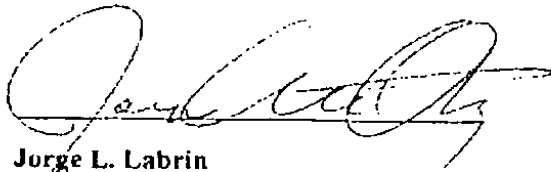
Article X**Management**
