**ARTICLE II - PRINCIPAL OFFICE**



**ARTICLE IV - MANAGEMENT**


The Company is a manager-managed limited liability company and the initial manager of the Company is Lance McNeill, 4000 State Road 60, East, Mulberry, Florida 33860.
