The undersigned hereby certifies that it has formed a limited liability company under the State of Florida.

ARTICLE I Name

The name of the limited liability company shall be OGLETHORPE STAFFING, LEX

ARTICLE II Address and Place of Business

- (k) Indemnify a Member or any other person to the same extent as a corporation may indemnify any of the directors, officers, employees, or agents of the corporation against expenses actually and reasonably incurred by him or it in connection with the defense of an action, suit, or proceeding, whether civil or criminal, in which he or it is made a party.
 - (1) Cease its activities and surrender this Certificate of Organization.
- (m) Have and exercise all powers necessary or convenient to effect any or all of the purposes for which the limited liability company is organized.
- (n) Transact any lawful business which the Members find to be in aid of governmental policy.
 - (o) Pay pensions and establish pension plans, profit-sharing plans and other incentive

plans for any or all of its employees.

- Be a promoter, incorporator, general partner, limited partner, Member, associate, (p) or manager of any corporation, partnership, limited partnership, limited liability company, joint venture, trust, or other enterprise.
 - Have and exercise all other powers necessary or convenient to effect its purposes. (q)

ARTICLE VI Registered Office and Registered Agent

The street address of the limited liability company's initial registered office is 625 Court Street, Suite 200, Clearwater, FL 33756 and the initial registered agent at such address is J. Paul Raymond.
