ARTICLES OF ORGANIZATION  
OF  
EQUITY INTERESTS, LLC,  
a Florida limited liability company**

Equity Interests, LLC, a Florida limited liability company (the "Company"), pursuant to Section 605.0202, *Florida Statutes*, and other applicable provisions of Chapter 605, *Florida Statutes*, does hereby adopt and file the following Articles of Amendment to its Articles of Organization:

1. The current name of the limited liability company is *Equity Interests, LLC*.
2. The current Articles of Organization of the Company were filed on October 31, 2019 and assigned document number L19000262174.
3. Article IV of the Articles of Organization of Equity Interests, LLC is hereby amended and restated in its entirety as follows:

**ARTICLE IV  
MANAGEMENT**


The Company shall be managed by the Manager or Managers as provided in the Company's Operating Agreement. The initial Manager of the Company is Equity Partners, Inc., a Florida corporation, who shall serve until replaced according to the provisions of the Company's Operating Agreement.

4. The initial Manager as specified in the Articles of Organization (prior to this Amendment), Michael D. Fess, with an address of 1300 North Semoran Boulevard, Suite 225, Orlando, Florida 32807, was removed as a Manager of the Company by the Company's Limited Liability Company Operating Agreement dated January 1, 2020 (the "Company Operating Agreement") and replaced by Equity Partners, Inc., a Florida corporation, and such removal is hereby confirmed.

5. Pursuant to the amendment of Article IV of the Articles of Organization, as set forth in Section 3 above, and the Company Operating Agreement, Equity Partners, Inc., a Florida corporation is the current Manager of the Company and shall be and remain the sole Manager of the Company, with an address of 1300 North Semoran Boulevard, Suite 225, Orlando, Florida 32807.

IN WITNESS WHEREOF, Equity Partners, Inc., a Florida corporation, appointed as the sole Manager of the Company pursuant to the Company Operating Agreement, has executed these Articles of Amendment to Articles of Organization this 27<sup>th</sup> day of January, 2021.
