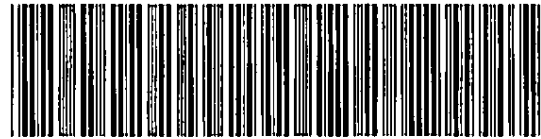

ARTICLE V – MANAGEMENT


