The undersigned, who intend to form and create a Limited Liability Company, as defined in Chapter 605 of the Florida Statutes, do hereby state and certify the following:

1. Name. The name of the Limited Liability Company shall be 1060 DAVIS ROAD, LLC.

2. Duration of Company. The company shall have perpetual duration.

3. Principal Office. The mailing address and street address of the principal office of the Limited Liability Company is 133 Browning Lane, East Palatka, Florida 32131.

4. Registered Agent and Office. The name and street address of the Limited Liability Company's initial registered agent is Kathleen H. Cold, One Independent Drive, Suite 2301, Jacksonville, Florida 32202.

5. Purpose of Company. The purpose for which the company is formed is to engage in any lawful acts or activities for which limited liability companies may be formed under Chapter 605 of the Florida Statutes.

The regulations may contain any provisions for the regulation and management of the affairs of the limited liability company not in consistent with law or the Articles of Organization.

12. No debt shall be contracted, nor liability incurred by or on behalf of this limited liability company except by one or more of its managers.


