ARTICLE VIII – MEMBER'S RIGHTS TO CONTINUE BUSINESS

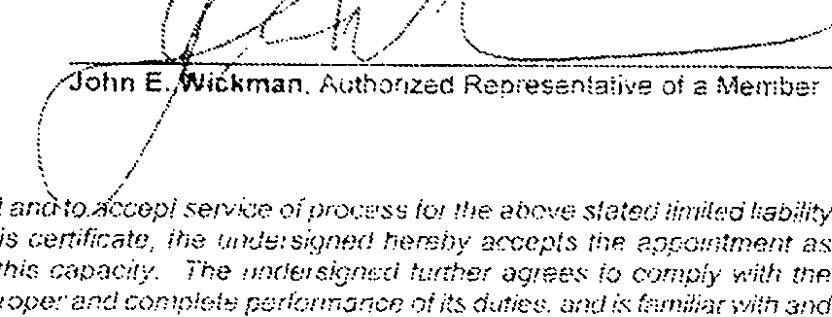

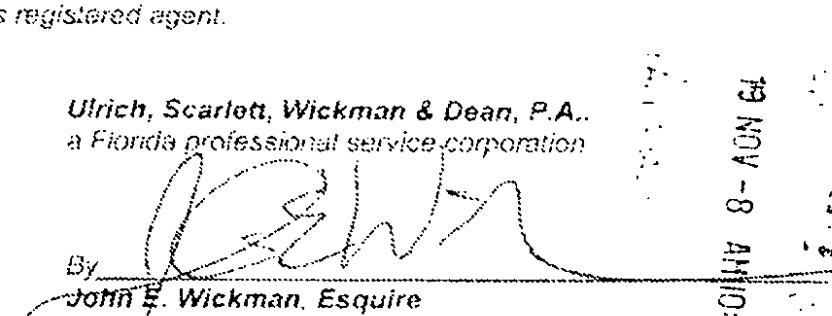
ARTICLE IX - EFFECTIVE DATE
