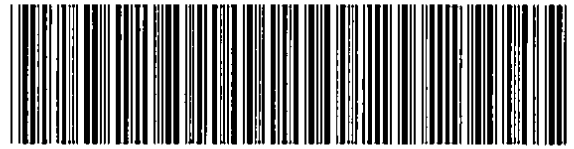

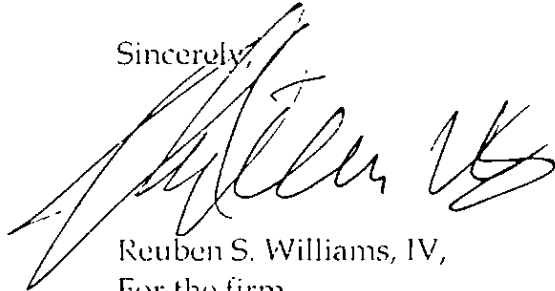

**ARTICLES OF ORGANIZATION**  
**OF**  
**SALT-VOC, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges and files these Articles of Organization.

**ARTICLE I - NAME**

The name of the Limited Liability Company shall be SALT-VOC, LLC ("Company").

The members of the Company shall contribute to the capital of the Company the cash or property as more fully set forth in the Operating Agreement.

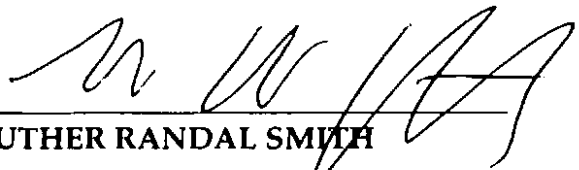
**ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS**

ARTICLE VII - MANAGEMENT

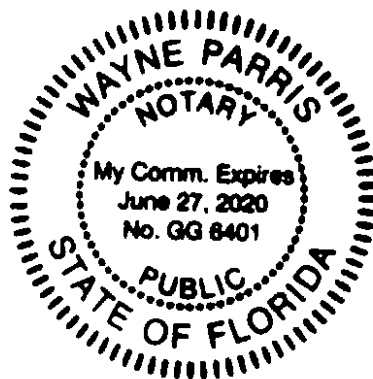

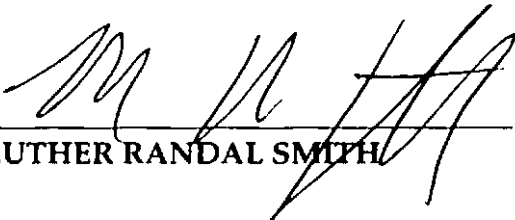
