The undersigned, who intend to form and create a Limited Liability Company, as defined in Chapter 605 of the Florida Statutes, do hereby state and certify the following:

1. Name. The name of the Limited Liability Company shall be DAVIS ROAD, LLC.

2. Duration of Company. The company shall have perpetual duration.

3. Principal Office. The mailing address and street address of the principal office of the Limited Liability Company is 133 Browning Lane, East Palatka, Florida 32131.

4. Registered Agent and Office. The name and street address of the Limited Liability Company's initial registered agent is Kathleen H. Cold, One Independent Drive, Suite 2301, Jacksonville, Florida 32202.

12. No debt shall be contracted, nor liability incurred by or on behalf of this limited liability company except by one or more of its managers.


