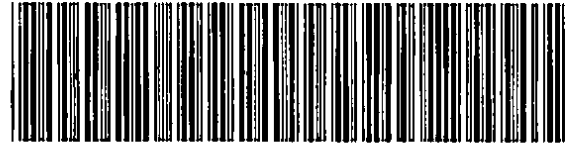

- III. Article I of the Articles of Organization of the Company is hereby amended to read in its entirety as follows:

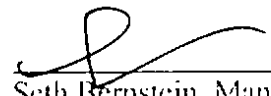
